### LOCATION

Onyx Retail Park is situated on the busy A633 Manvers Way on the outskirts of Wath upon Dearne, between Barnsley and Rotherham.

The Dearne Valley area has seen massive investment and development with a wide variety of occupiers and large employers such as Next, Ventura, Morrisons, Tesco, B&Q, Dearne Valley College, South Yorkshire Fire & Rescue Training Centre and many more.

1,300 new homes have been built within one mile of Onyx Retail Park. Close by is RSPB's Old Moor nature reserve which attracts over 100,000 visitors per year.

## DESCRIPTION

The unit is very prominent and has a full height glazed shopfront and return frontage. It is approximately 1,250sq ft with open plan retail area, rear store and office area and wc's.

Onyx Retail Park comprises 17,500 sq ft of mixed retail and food occupiers including a 4,000 sq ft SPAR, together with variety of National and Local retailers: - Greggs, Dominos, Subway, Barnardos, The Groom Room, Beauty at Heart, Coffee Street, Onyx Fish & Chips and Holy Cow Burger Co.
